2024 MEDICAL RELEASE FORM

Consent to medical Treatment & Release of Liability (Read this before signing below)

Head Coach Fernanda Nelson

Nelson became the fifth head coach in FAU volleyball history after serving as an assistant at FGCU four seasons.

FAU had a fantastic year in 2023, as the Owls enjoyed another successful season in the AAC and going to Post Season with a 20 win season. Coach Nelson has gotten FAU to an RPI of 86 and 7 consecutive Conference USA Tournament appearances.

While at the helm of the Owls, she coached the NCAA Top Setter in Assists two years in a row, Defensive Player of the Year in 2019, Conference USA Setter of the Year in 2018, 18 C-USA All Conference Team Honorees, 4 players earned AVCA All Region Team, and 3 C-USA All Freshman Team selections.

One of the best setters in the storied history of the Brazilian National Team and named Brazil's best setter in 1997. Nelson played 8 years Professionally in Brazil.

The position in the state of Florida came after eight years as both a player and a coach at National American University in Rapid City, South Dakota. Nelson arrived at NAU in 2000 and earned second-team NAIA All-American honors as a freshman. She was National Player of the Year as both a sophomore and a senior and led NAU to a national championship as a junior. Nelson ended her career as a three-time All-American selection. She was named to the NAU coaching staff immediately following the conclusion of her playing career. While an assistant, NAU won four straight regional championships and the 2006 NAIA National Championship.
